3. **PARK AND RECREATION DEPARTMENT**

  - e. Two recruits – Tyler Double and John Laubat – will be on a 1-year probation and will attend Fire Academy next Fall. Medical training is in the Spring. Bill motioned to add Mr. Double and Mr. Laubat to the Fire Departments roster, Tim seconded. Motion carried. 5-0

- C. Ameriscapes snow removal contract renewal – Bill motioned to renew the contract, Connie seconded. Motion carried. 5-0
- D. Complete transfers from former Treasurer and Clerk to new officers – all bank accounts, emails and vendor accounts.
