Finance – A fraudulent check was created and cashed from the Fire Department account in the amount of \$4,750 at a bank in Florida. Tri-County Bank in Brown City caught the check and has returned the funds to our account.

Summer taxes are going good, payments are coming in, due date is September 14.

Joel Champ from BS&A – guest speaker – The company is transitioning to the cloud, and the county is going live with their online platform next summer. The transition will become mandatory if we continue using their services. There are many features and upgrades – residents can see their tax bills online, the county can import and export data they need, we get unlimited users and backups. The County is offering to help with the cost of the transition in the amount of \$5,000. The offer expires October 31. The county will also pay for the training in Port Huron. Financials is a separate training and cost. Joel will get us that information. There is also online training and webinars that we will have access to once we agree to upgrade.
